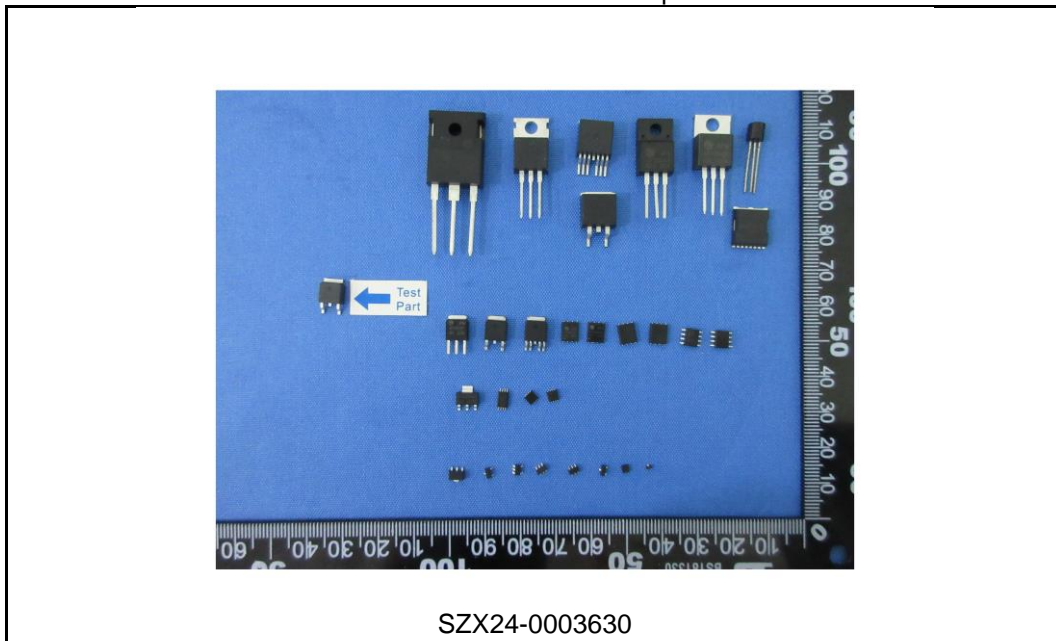

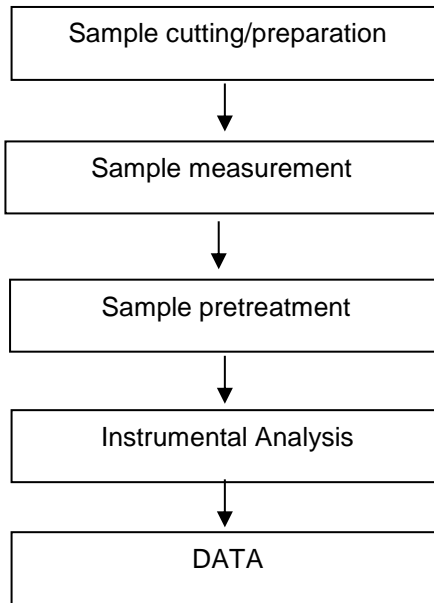

### Testing Flow Chart



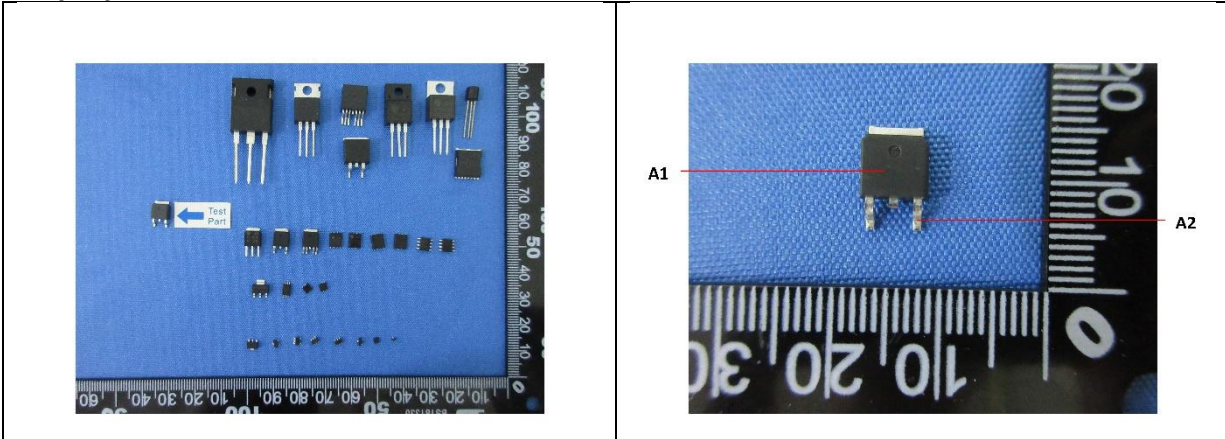
